	The Marijuana Control Board (MCB) currently has only one dedicated industry seat; another seat is designated for public/industry and leaves open the potential for a prohibitionist appointment. The Alcohol Beverage Control Board has two dedicated industry seats.
Marijuana Control Board and AMCO	The current administration has publicly stated that they intend to introduce legislation that could disempower the Alcohol and Marijuana Control Office and seek to move the quasi- judicial control boards under the Division of Corporations, Business & Professional Licensing. The AMIA is concerned that such legislation would undermine the regulating agency's ability to act independently and without political influence.
	In 2019 a vocal opponent of legal cannabis, Vivian Stiver, was nominated to the MCB. The industry opposed the nomination on the grounds that the appointee would be empowered to profoundly and negatively impact legal operations. The AMIA will loudly oppose any MCB candidate that seeks to undermine or obstruct the legal cannabis industry. Any appointee to the MCB should support the mission of legal cannabis.
